Wisconsin State Statutes; Chapters 69, 154, 157 & 445 were researched to determine depth of plot for a natural or green burial. No indication of depth was found.

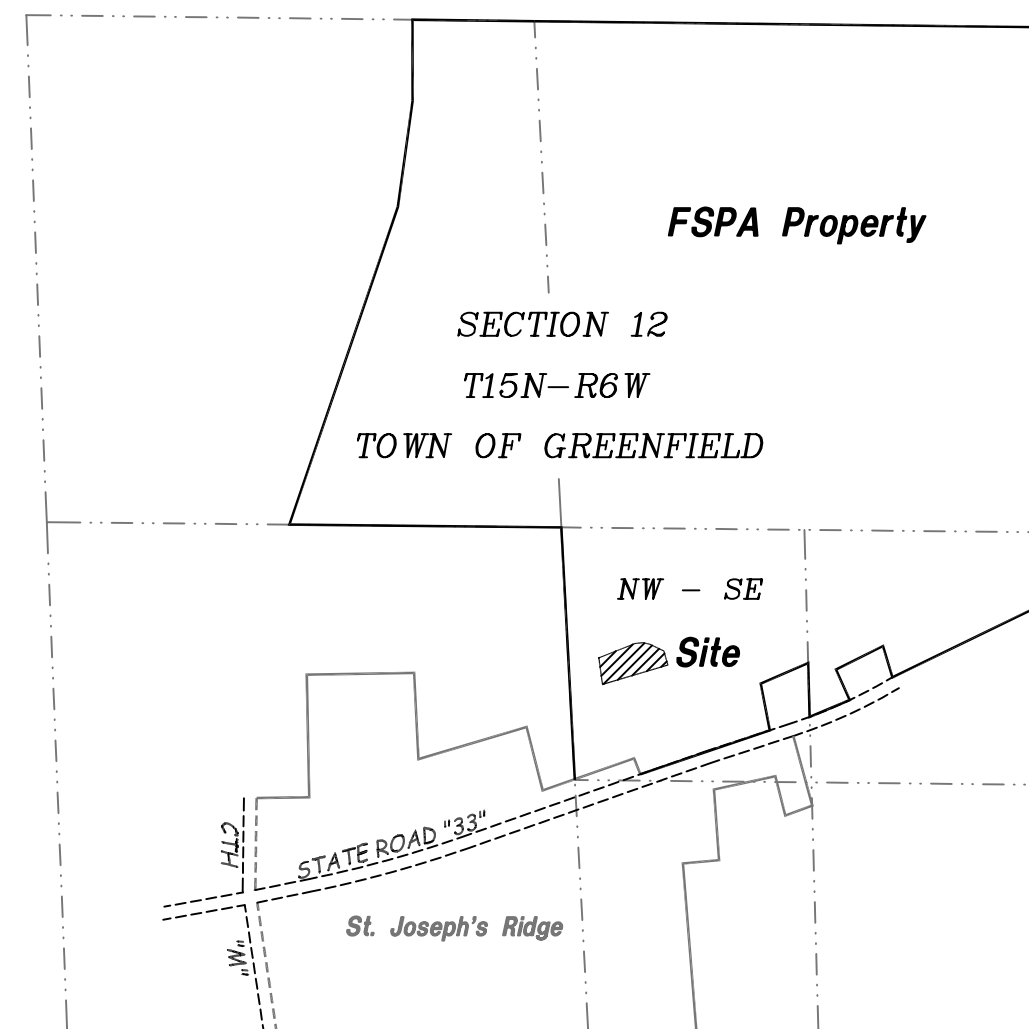

Proposed depth of burial for this Plat is 5.5 feet.

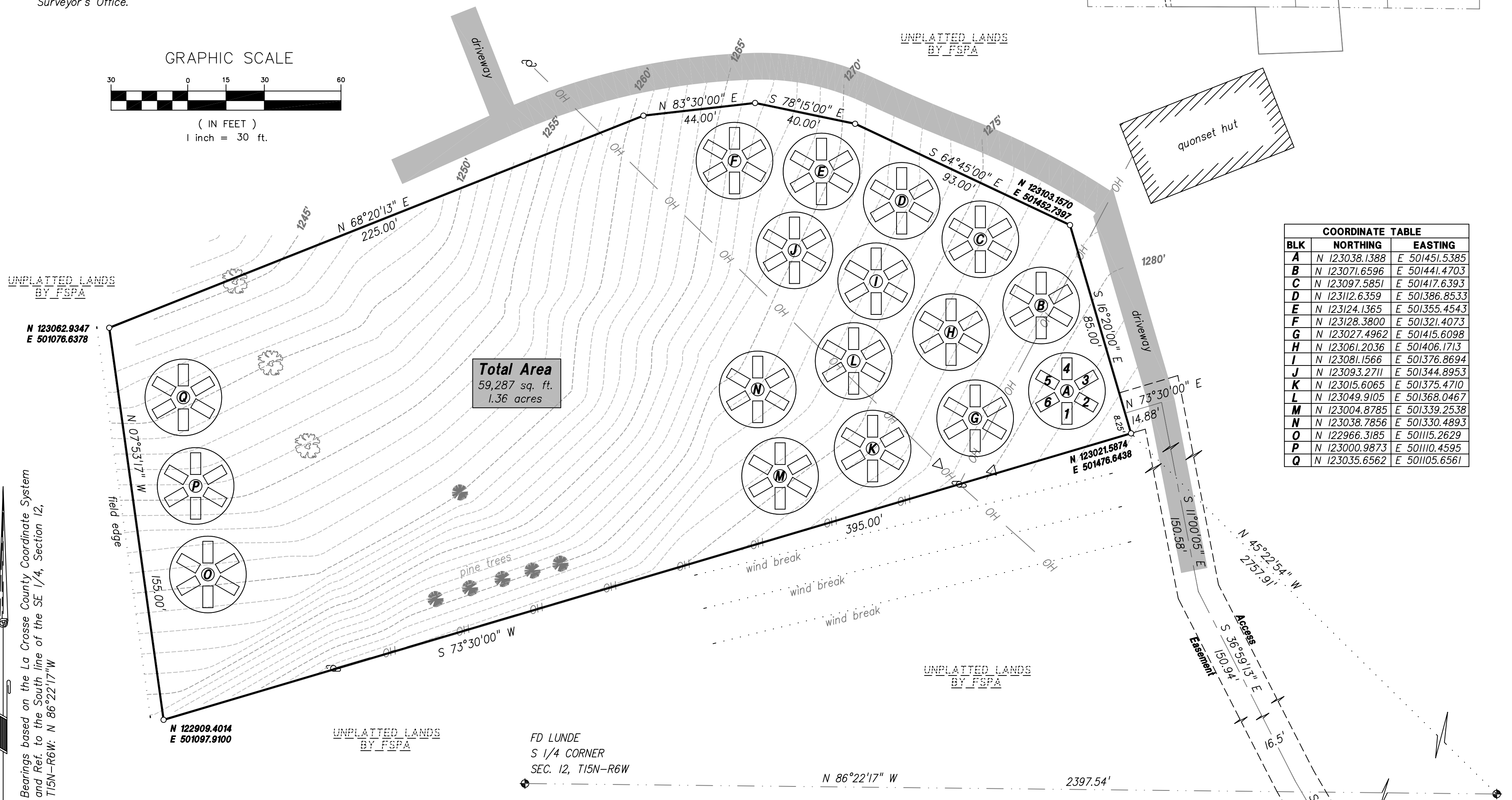
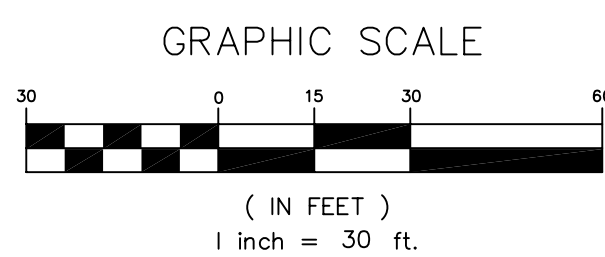
Plots are reserved for the exclusive use by members of the Franciscan Sisters of Perpetual Adoration. Covenants and restrictions are held by the FSPA.

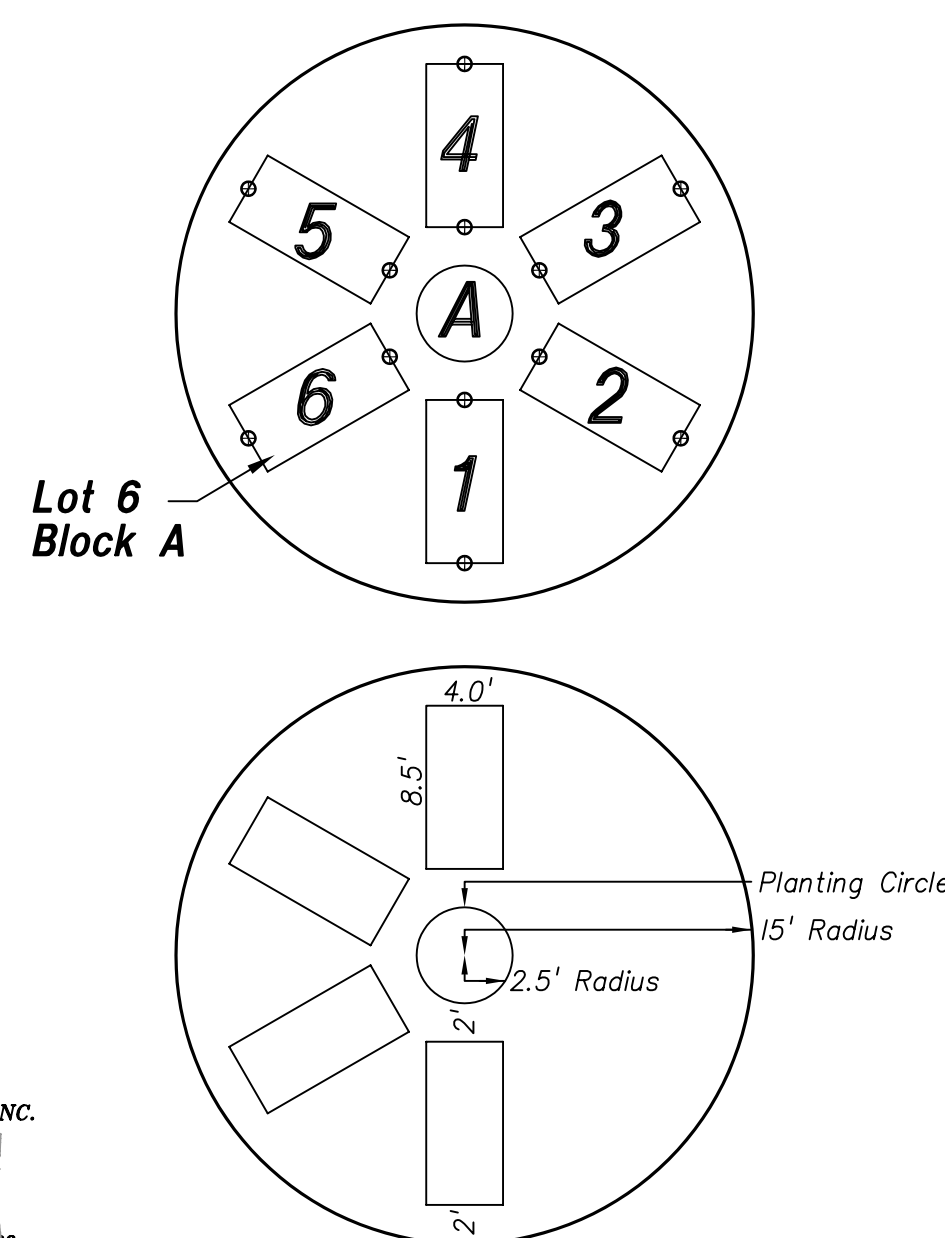
